Reminder:

Once becoming licensed as a hauler:

- The PMMB-79 Milk Hauler's Report must be completed and filed by all Milk Haulers on a monthly basis. This report identifies the prior month's hauling activity and must be filed on or before the 30th of each month. A report is required even if there was no activity to report. Failure to comply with this filing requirement may be subject to possible legal referrals.
- In addition to the annual fixed fee of \$30.00, all licensed Milk Haulers shall pay the sum of \$.005 per hundred weight on all milk hauled, computed as follows:
 - A. All milk picked up at a producer's farm located outside of PA and delivered to a dealer or handler located within PA.
 - B. All milk picked up at a producer's farm located within PA and delivered to a dealer or hauler located within or outside PA.
 - C. The payment due must accompany the milk hauler's monthly report.

There is a \$20.00 service charge for any returned checks.
