The hearing that is scheduled for October 9, 2018 follows a hearing that was held in 2014 and 2015 over several days that resulted in OGO A-992 (Nov. 4, 2015) (that proceeding will be referenced as Procurement I). That OGO and the hearing record from Procurement I opened the door to the upcoming hearing. PAMD's outside experts feel it is necessary to review material from Procurement I. Since neither expert was involved in that prior hearing, they need permission to review the materials that are subject to the protective order covering that hearing. 
