Doug:

Thank you for this. Board Staff agreed to PADC's proposed date changes even though the time for surrebuttal was being changed from the 9<sup>th</sup> business day (and 13<sup>th</sup> calendar day) after rebuttal to the 8<sup>th</sup> business day (and 12<sup>th</sup> calendar day) after rebuttal. With this new schedule, surrebuttal is due on the 6<sup>th</sup> business day (and 8<sup>th</sup> calendar day) after rebuttal (which is also price day, as it was with the original schedule, but then we had more days to work with).

There are obviously many details and issues involved in this hearing, at least some of which are likely to surface in rebuttal, and the time for responding to them in surrebuttal seemed already short. For a matter of this magnitude, is the proposed schedule sufficient for a comprehensive response? If that had been the schedule proposed by PADC, it is doubtful Board Staff would have agreed to it.

Perhaps the Board would consider having the first day of the hearing on October 9 instead of October 3 to give more time for surrebuttal. Or if the hearing is to begin as scheduled on October 3, perhaps the Board would reconsider and schedule surrebuttal for September 24 as proposed by PADC and as agreed to by the parties.
