DISCUSSION: Attorney Saylor presented that Foremost Farms USA, Cooperative has submitted an application for a dealer license, for 2017-2018. Applicant will purchase milk from a cooperative in PA. Applicant operates dairy manufacturing plants, and sells bulk milk to dealers. A waiver has been provided in lieu of a bond. Appropriate staff has reviewed the application to ensure that all forms and fees have been received and are in order, and that the applicant has met the requirements of the Milk Marketing Law. With Board approval of this application, a dealer license will be issued.

Appropriate staff has reviewed the application to ensure that all forms and fees have been received and are in order, and that the applicant has met the requirements of the Milk Marketing Law. With Board approval of this application, a subdealer license will be issued.
