DISCUSSION: Attorney Petrascu presented **1. Legal Docket No. CE-21-005 DFA Dairy Brands Fluid, LLC – Garelick -New York** provided controlled products at prices below PMMB minimums during the month of September 2021. A consent order was signed and a penalty of \$800.00 was paid.

DISCUSSION: Attorney Petrascu presented **1. Legal Docket No. CE-22-001** DFA Dairy Brands Fluid, LLC – Lebanon for submitted bids to The Emergency Food Assistance Program ("TEFAP") for sales of price-controlled products using bid prices below PMMB minimum prices. A consent order was signed and acknowledging the violation and consenting to the settlement of the citation through the donation of the full amount of bid milk in satisfaction of the awarded bid.

DISCUSSION: Attorney John Howard inquired what was the volume of milk. Attorney Petrascu stated it to be 5 deliveries, each one at the amount of \$12,317.67 from February 1st through March 29th

DISCUSSION: Chairman Barley stated that there have been some misunderstandings between our Staff, under leadership of Dr. Hardbarger, and in working with folks with PDA, and with folks in USDA. There is a plan now, and there should be no misunderstandings on how to bid in Pennsylvania going forward.

Attorney Howard Thanked Dr. Hardbarger on behalf of Dept of Ag, for doing that. He further mentioned that it is certainly much better than several months ago.

Dr. Hardbarger expressed gratitude and credit given to the staff team of 4 who have worked on that. She stated that USDA has assigned a deputy to work with PMMB and she had regular communication with him, plus made themselves available, as well as calculating the minimum bids with each solicitation that comes out. We hope the combined efforts will alleviate any problems in the future. Also, we are happy in seeing that the PA milk dealers are receiving the contract awards, because everyone is following the law.
